



TreePAC Newsletter – January 2021

Hello everyone and Happy New Year! As always, we hope this newsletter finds everyone safe and healthy.

For newcomers to our cause, TreePAC are focused first and foremost on getting the **2009 Interim Seattle Tree Ordinance** made into a full-fledged (and uniformly enforced) law across the City of Seattle. Please help us keep tree protection and urban canopy restoration a high priority and focus in Seattle and surrounding areas.

2021 priorities: 2021 will be a critical year for WA forests, both wild and urban:

1) **Continued focus to improve** the [2020 Seattle Draft Urban Forest Mgmt Plan](#) – as stated several times over the past months – there are a lot of things in this plan with notable room for improvement to protect and enhance Seattle's urban canopy – PLEASE submit input and suggested changes to the City, City Council and Mayor: Council@seattle.gov; Jenny.Durkan@seattle.gov; Sandra.Pinto_de_Bader@seattle.gov (Seattle Urban Forestry Commission); and Maketa.Brazier@seattle.gov (Office of Sustainability & Environment).

You can also submit comments through the Don't Clearcut Seattle site: [submit comments to the Mayor and City Council](#) – in addition to our regular, longstanding request: If you see something in your neighborhood, i) ask, ii) document/photograph it and iii) submit it, please.

2) **Statewide:** [WA Can't Wait](#).

This effort – being led by [Futurewise](#) and [other groups](#), seeks to provide input to many key cities and urban areas statewide who are currently finalizing 10-year comprehensive plans – in the case of King, Pierce and Snohomish County for example, these are due starting in 2024. The *Washington Can't Wait Campaign* is urging the Legislature to update the requirements in plans to include Climate Resilience, Equity and Affordable Housing as goals.

What TreePAC are focused on is making sure that urban, suburban forests and tree/habitat resources are not ignored by such suggested proposals. Our state is still undergoing a turbulent time, especially from a climate, wildlife and natural resources perspective – **it is essential to make sure trees and all the related ecosystems that depend on them will survive and thrive in the future** of our state, the Pacific Northwest and beyond. You can make a difference for trees on this plan, both directly to Futurewise and its partners via the link above and to your [WA Legislators](#) and [Gov. Inslee](#) too.

2021 Priorities (cont.)

3) Statewide: [WA State Forest Plan](#).

This [plan](#), initially released by DNR in late October 2020, will govern how WA manages and protects/enhances its various [forest and related resources for the next ten years](#). Input and updates to the state's forest plans should be regular, ongoing, and with **a strong presumption of protection first - the same as that of the urban forest**. As the laws to enact this plan are just in the beginning stages, **now** is the time to [contact your Legislator](#) and [DNR](#) to provide critical input on behalf of trees! Specifically, DNR is filing legislation to update provisions in their urban and community forestry program to fund and help communities to develop Urban Forest Management Plans and Urban Forestry Ordinances. Last year's bill [HR 2768](#) almost passed and will be re-introduced with a new bill number this year.

4) County and local City forest plans – Several major counties also have tree protection/planting programs already well underway, including [King](#), [Snohomish](#), [Spokane](#), and [Clark](#) among others, and cities within same. These programs need to continue and expand, as *protecting* trees at the local level requires constant vigilance and monitoring/data collection; *planting* trees and *expanding tree canopy* is nowhere near as simple as 'plant and move on' - new trees require care and nurture or they will simply not survive. Contact your County or City govt and let them know you want them to **protect** existing and **plant** more new, native PNW trees!

Feature: Native Trees of the PNW (a continuing series) [*\(return to top\)*](#)

We at TreePAC talk a lot about *protecting* the trees of Seattle, but for those of us who aren't arborists, what *are* the trees of Seattle?

Here's two more (last issue was [Noble Fir and Pacific Dogwood](#)) – the **Pacific Silver Fir** and **Pacific Madrona**:

Pacific Silver Fir ([Abies Amabilis](#)) A native PNW fir, ranging from BC all the way down to northern California, which goes by several other common names including White Fir and Silver Fir. Commonly seen on our familiar rainy, dark Cascade and PNW western mountain slopes, around here usually seen around 2-5,000 feet in elevation. Typically grow from 100-150ft tall, avg trunk diameter typically up to 3ft.



The **Pacific Madrona** ([Arbutus menziesii](#)) – also ranges from BC down to California. This is an evergreen tree, but not a conifer. Besides the spring displays of flowers and fall red berries, another distinctive feature is the orange-red bark that peels away in sheets over time. Typical height is from 30-80 feet but larger isn't uncommon and some can also reach a trunk diameter of 5-8 feet. The leaves stay on the tree for several years before they fall off and are replaced, in wetter areas can show leaf discoloration due to fungal infection.
